Vayas, Former VC, RTU, Kota; Prof. S.K. Kak, Former, VC, Jaypee University, Solan; Chairman, UGC; Director General, IAMR, New Delhi and Director General, ICAR could not attend the meeting due to their prior engagements.

Prof. Anil D. Sahasrabudhe, Chairman-AICTE welcomed the members to the 107th Executive Committee meeting. He apprised all the members about the recent achievements of AICTE. including PMSSS being continued which has garnered a good response from Jammu and Kashmir and Ladakh. The number of applicants has crossed 21000 for the scheme. Further, Smart India Hackathon 2017 has been a huge success, therefore, it has been planned to conduct Hackathon 2018 with more problems from all Ministries of Govt. of India, State Govts and industries as well. There will also be a open category under which problems will be collected from students, faculty and even common citizens in India. AICTE further plans to include hardware along with software Hackathon to develop prototypes for Start-ups and has initiated talks with different Ministries in this regard. It is planned to hold Hackathon in 5-6 countries as well.

The members were informed that AICTE is getting land/office in different Regions for smooth functioning. DTE, Govt of Assam has agreed to allot 2 acres of land for AICTE Camp office at Guwahati. Similarly there is a commitment from Govt of Tamil Nadu to give about one acre plot in

the heart of city. Commitment from Govt of Gujarat for 5 acres plot is already under process. At Headquarters, New Delhi some part of land under UGC's possession will be requested for building quarters for officials' residence. The Members were informed about the introduction of mandatory Internship for students and signing of MoUs with different organizations in this regard with a mention of Internshala, NETiit and ECI.

Dr. M.P. Poonia, Vice Chairman. AICTE informed the Members about the Green Campus competition program as a part of 'Swachh Bharat' program being initiated for AICTE approved institutions with a target of 10,000 plus institutions before 2nd October 2017. A theme paper on the said subject will also be made available on the AICTE web portal. As per the Government policy, each Member of Parliament is adopting a village under Member of Parliament - Local Area Development Scheme (MP LADs). If, Members of Parliament are encouraged to adopt an educational institution located in the said village, it will be beneficial to the students and institutions and also help in developing the village/town/districts in many ways.

Mittal Member Secretary pointed out that while conducting consultative meetings for the revision of 7th Pay commission for technical teachers, it was brought to the notice of AICTE that The National Fee Committee constituted by AICTE/MHRD had only fixed upper limit but not fixed lower limit of fee to be charged by technical institutions and the State Govts have fixed unreasonably low fees in certain states, thus made technical institutions financially unviable. The Executive Committee decided that the matter may be referred to Justice Sri Krishna, who headed National Fee Committee for his consideration.
