At the outset, the Chairman welcomed the members of the Council. The Council discussed and deliberated on certain issues related to technical education in the country.

- □ The Chairman briefly apprised the members about the need of switchover from calendar based approval process to "anytime round the year approval". It has been desired by the Members that AICTE should write to all the State Governments explaining the approval process of AICTE in detail so that the State Governments and concerned Universities may be able to frame a academic calendar for admissions to avoid any problem in the admission process.
- □ Some Members expressed their concern about the acute shortage of qualified faculty in technical institutions. Attention of the Council was also drawn about the non-inclination of students towards the PG and Doctoral qualifications in Engineering & Technology discipline. It has been desired that AICTE should take necessary steps to attract students for higher qualifications and research.

The Chairman informed the members about the Report of the Committee under the Chairmanship of Prof. P. Rama Rao for faculty development in Engineering & Technology, which will be sent to the members separately. He invited the comments and suggestions of the Members on the Report.

The Chairman also apprised the Members that the same Committee is also reviewing the matters related to Pharmacy and Management education co-opting members of relevant disciplines.

The matter regarding Diploma level education in Engineering & Technology also came up for discussion. It was informed that the number of seats available for students seeking admission in Diploma level institutions is very less in comparison to the demand in some states. The Council felt that the participation of private promoters in the diploma level institutions is not very encouraging keeping in view the high costs involved in establishing such institutions as per norms of the AICTE. The members suggested that AICTE should take necessary steps in order to encourage the self-financing institutions for establishing diploma level institutions in Engineering & Technology. It was decided that a Committee may be constituted to look into the matter.
