सं० एफ० 37-3/लीगल/2000--अखिल भारतीय तकनीकी शिक्षा परिषद् अधिनियम, 1987 (1987 का 52) की धारा 23 की उप-धारा (1) के अंतर्गत प्रदत्त शक्तियों का प्रयोग करते हुए अखिल भारतीय तकनीकी शिक्षा परिषद् एतद् द्वारा "अखिल भारतीय तकनीकी शिक्षा परिषद् (नई तकनीकी संस्थाएं खोलने, पाठ्यक्रम अथवा कार्यक्रम शुरू करने के लिए अनुमोदन प्रदान किया जाना तथा पाठ्यक्रमों अथवा कार्यक्रमों के लिए प्रवेशार्थी क्षमता के लिए अनुमोदन दिया जाना) विनियम, 1997" नामक विनियम में संशोधन करती है अर्थात्—

1. (1) इस संशोधन को अखिल भारतीय तकनीकी शिक्षा परिषद् (नई तकनीकी संस्थाएं खोलने, पाठ्यक्रम अथवा कार्यक्रम शुरू करने के लिए अनुमोदन प्रदान किया जाना तथा पाठ्यक्रमों अथवा कार्यक्रमों के लिए प्रवेशार्थी क्षमता के लिए अनुमोदन दिया जाना) संशोधन विनियम, 2000 कहा जाये।
- (2) ये विनियम शासकीय राजपत्र में प्रकाशन की तिथि से लागू होंगे।
2. अखिल भारतीय तकनीकी शिक्षा परिषद (नई तकनीकी संस्थाएं खोलने, पाठ्यक्रम अथवा कार्यक्रम शुरू करने के लिए अनुमोदन प्रदान किया जाना तथा पाठ्यक्रमों अथवा कार्यक्रमों के लिए प्रवेशार्थी क्षमता के लिए अनुमोदन दिया जाना) संशोधन विनियम, 1997 में विनियम 2, (2) जिसे विनियम 1994 के संशोधन स्वरूप जोड़ा गया था, एतद्वारा वापस लिया जाता है।
3. संशोधन विनियम, 1997 में,
(क) विनियम 8 (ग) में "वास्तुशिल्प, होटल प्रबंध एवं खानपान प्रौद्योगिकी" से पहले "एग्रीकल्चर, एमसीए" शब्द जोड़ दिए जाएं।

(ख) विनियम 8, उप-विनियम 8 (iv) के स्थान पर निम्नलिखित को प्रतिस्थापित किया जाए :—

“8(iv) विनियम 8(i) में विनिर्दिष्ट रूप में विद्यमान भूमि पर पूर्णतः सज्जित स्थाई भवन, जो कम से कम प्रथम वर्ष (के दिवसों) हेतु पर्याप्त हो, विनिर्धारित अवधि के अन्दर अर्पित होगा”।

4. संशोधन विनियम, 1997 में निम्नलिखित नोट को अनुसूची के बाद जोड़ा जाए :—

No. IRS 124C 3256 NAK—In exercise of the powers conferred by Section 19 read with sub-section (2) of Section 12 of the Banking Companies (Acquisition and Transfer of Undertakings) Act, 1970 (5 of 1970) the Board of Directors of Canara Bank, in consultation with the Reserve Bank of India and with the previous sanction of the Central Government, hereby makes the following regulations namely :

1. (1) These Regulations may be called the Canara Bank Officer Employees' (Discipline & Appeal) (Amendment) Regulations, 2000.
- (2) They shall come into force on the date of their publication in the Official Gazette.
2. In the Canara Bank Officer Employees' (Discipline & Appeal) Regulations, 1976, (hereinafter referred to as the said regulation), in regulation 6, —
 - (i) for Sub-regulation (3), the following sub-regulation shall be substituted, namely :

“(3) Where it is proposed to hold an inquiry, the Disciplinary Authority shall, frame definite and distinct charges on the basis of the allegations against the Officer employee and the articles of charge, together with a statement of the allegations list of documents relied on along with copy of such documents and list of witnesses along with copy of statement of witnesses, if any, on which they are based, shall be communicated in writing to the Officer employee, who shall be required to submit, within such time as may be specified by the Disciplinary Authority (not exceeding 15 days), or within such extended time as may be granted by the said Authority, a written statement of his defence :—

“Provided that wherever it is not possible to furnish the copies of documents, Disciplinary Authority shall allow the Officer employee inspection of such documents within a time specified in this behalf ;

- (ii) for sub-regulation (10), the following shall be substituted, namely :

“(10) The Inquiring Authority while adjourning the case as in sub-regulation (9), shall also record by an order that the Officer employee may for the purpose of preparing defence—

- (i) complete inspection of the documents as in the list furnished to him immediately and in any case not exceeding 5 days from the date of such order if he had not done so earlier as provided for in the proviso to sub-regulation (3);
- (ii) submit a list of documents and witnesses; that he wants for the inquiry ;
- (iii) give notice within ten days of the order or within such further time not exceeding ten days as the Inquiring Authority may allow for the discovery or production of the documents referred to in item (ii).

Note : The relevancy of the documents and the examination of the witnesses referred to in item (ii) shall be given by the officer employee concerned.

No. ODAR/1/2000—In exercise of the powers conferred by section 19 read with sub-section (2) of section 12 of the Banking Companies (Acquisition and Transfer of Undertakings) Act, 1970 (5 of 1970), the Board of Directors of UCO Bank

in consultation with the Reserve Bank of India and with the previous sanction of the Central Government, hereby makes the following Regulations to amend further the UCO Bank Officer Employees' (Discipline and Appeal) Regulations, 1976 namely :—

1. SHORT TITLE AND COMMENCEMENT

(1) These Regulations may be called UCO Bank Officer Employees' (Discipline and Appeal) (Amendment) Regulations, 2000.

(2) They shall come into force on the date of their publication in Official Gazette.

2. In the UCO Bank Officer Employees' (Discipline and Appeal) Regulations, 1976, in regulation 14, in sub-regulation (1), in clause (a), in sub-clause (ii), for item (2), the following shall be substituted, namely :—

“(2) Where the enquiry is held by an outside agency, 1/3 of the basic pay which the officer employee was drawing on the date prior to the date of suspension for the next three months and 1/2 of the basic pay which the officer employee was drawing on the date prior to the date of suspension for the remaining period of suspension”

No. F. 37-3/Legal/2000—In exercise of the powers conferred by sub-section (1) of section 23 of the All India Council for Technical Education Act, 1987 (52 of 1987), the All India Council for Technical Education hereby amends the regulations, the All India Council for Technical Education (Grant of approval for starting new technical institutions introduction of courses or programmes and approval of intake capacity of seats for the courses or programmes) Regulation, 1997, namely—

1(1). This amendment may be called the All India Council for Technical Education (Grant of approval for starting new Technical Institutions, introduction of courses or programmes and approval of intake capacity of seats for the courses or programmes) Amendment Regulations, 2000.

(2) These regulations shall come into force from the date of their publication in the official Gazette.

2. In the All India Council for Technical Education (Grant of approval for starting new technical institutions, introduction of courses or programmes and approval of intake capacity of seats for the courses or programmes) Amendment Regulation, 1997, the Regulation 2, (2) which was inserted as amendment to Regulation—1994 stands withdrawn.

3. In Amendment Regulation, 1997.

(a) In Regulation 8(c), before the words "Architecture, Hotel Management...." the words "MBA, MCA" shall be inserted.

(b) In Regulation 8, sub-Regulation 8(iv) shall be replaced by:—

"8(iv) A furnished permanent building atleast adequate for the first year on the land as specified at 8(i) shall be required within the stipulated period"

4. In the Amendment Regulation, 1997, following note shall be added after the Schedule :

"Note : The Council on advice of the Executive Committee may modify the prescribed dates as mentioned in the schedule. The decision of the Council regarding the dates shall be final".
