 - (d) Student has not been admitted under Management quota.
 - (e) The Annual Income of his / her parents from all sources does not exceed Rs. 6 lakhs per annum.
 - (f) Student is admitted and pursuing the course for which the claim has been made.
 - (g) Student belongs to category mentioned against his / her name and as per the certificate submitted by him / her for the purpose.
