Subject: Extension of date of participation in Orientation/ Refresher Courses for promotion under CAS – reg.

Sir/Madam,

You are aware that the All India Council for Technical Education (AICTE) has been established by an Act of Parliament for proper planning and co-ordinated development, regulation and maintenance of Norms and Standards in the Technical Education system throughout the Country. Consequent upon revision of pay scales based on the recommendations of the 7<sup>th</sup> Central Pay Commission, AICTE formulated a revision of pay scales and service conditions for degree and diploma level technical institutions in the country. This Council vide Sl. No. 11 of Gazette Notification dated 20.05.2020 had clarified that there shall be no relaxation in the mandatory requirement of total duration of programmes for promotion under CAS for faculty members/ Librarians/ PTIs in Degree/ Diploma level Institutions. It was also clarified that one-time extension for completion of these programmes had already been given until 07.11.2015.

This Council has, however, received a number of representations regarding extension of date of participation in orientation/ refresher courses for promotion under CAS similar to the extension up to 31.12.2018 granted by the University Grant Commission (UGC). The Executive Committee of AICTE in its 144<sup>th</sup> Meeting deliberated the above issue and decided that in order to have a parity between the AICTE and the UGC, and in line with the clarification given in the UGC Public Notice 2-16/2002(PS) Pt. F1.II dated 16<sup>th</sup> October 2018, the date of participation in Orientation/ Refresher Courses/ Short-term training programmes/ Continuing Education Programmes for promotion under CAS for faculty members/ Librarian/ PTIs in Degree/ Diploma level institutions be extended upto 31-12-2018. Following to the above decision, Public Notice has since been issued and uploaded on the website of AICTE for information and necessary action.
