

| Q. 1. | Where to send the queries related to portal and approval related issues for the approval process 2024-25? If I have the problem with respect to application while applying, whom to contact and where to contact? |
|-------|--|
| Ans. | Institutes are requested to raise queries only through online Central Support System (CSS) available on AICTE website under Approval Process 2024-25 quick links. No queries through email will be entertained. |
| Q. 2. | Can a New Institute apply for UG and PG in Engineering and Technology? |
| Ans. | No. Institute can apply only for UG Course(s). A PG Course(s) can be Started only after the completion of the first Batch of relevant UG course. |
| Q. 3 | How much land is required for Establishment of New Engineering College with UG program? |
| Ans. | Institute should have required land as per FSI/FAR as applicable (Rural / Urban/ Mega/ Metro Cities) based on required built up area. For details, refer APH 2024-27, Chapter-1, and Annexure-1 |
| Q. 4 | Is AICTE Approval for New and Existing Pharmacy and Architecture Institute / Program discontinued? |
| Ans. | Yes. As per directives from Hon'ble Supreme Court, AICTE has discontinued the grant of Approval for Institutions offering Pharmacy and Architecture programmes. |
| Q. 5 | Can new Institute apply for obtaining approval for multiple programme(s) / Level(s)? |
| Ans. | Yes, New Institute may apply for one or more Programme(s) / Level(s) |
| Q. 6 | Which courses a New Institute in Engineering and Technology can opt? |
| Ans. | New Institute in Engineering and Technology is required to opt for minimum THREE core branches (including Multidisciplinary /Region Specific branches/ courses) and ONE Emerging area course. |
| Q. 7 | If New Institute apply for Multiple Programs, say for Engineering & Technology and Management (MBA), what will be the Security Deposit amount? |
| Ans. | The Security Deposit shall be the addition of all Program (s) applied for. |
| Q. 8 | How many Emerging Courses can a New Institute opt? |
| Ans. | New Institute is required to opt for THREE core branches (including Multidisciplinary / Region Specific branches/courses) and ONE Emerging area in Engineering and Technology and other courses can be opted in Emerging Area with maximum celling of 360 seats. |
| Q. 9 | As a new institute where applicant Institute can submit the application for obtaining AICTE Approval? (Website Address) |
| Ans. | The New Institution is required to visit NSWS website to create login credentials & select AICTE approval under approval tab for navigating to AICTE portal. NSWS Website: https://www.nsws.gov.in and AICTE Website Address: www.aicte-india.org. |



| Q. 10 | For existing institutions applying for only EoA, Is it mandatory to update faculty/ Infrastructure/ other details before submission of application? |
|-------|---|
| Ans. | Yes. Institute can update the details of faculty / Infrastructure / Others at later dates AICTE notified by AICTE by time to time. One-minute submission of application provision is made available ONLY for Simple Extension of Approval (Only EoA cases). |
| Q. 11 | How many divisions can a new institution apply for Under Graduate/ Diploma Engineering and Technology? |
| Ans. | Institute can apply for 6/12 divisions with division size of 60/30 with maximum allowed intake of 360. |
| Q. 12 | Whether an Institute can Increase Intake without NBA/NAAC ? Is there any limit for Increase in Intake /Starting New Course(s)? |
| Ans. | YES. There is NO Limit on Increase in intake/New Course(s). However, the Institute needs to fulfill the requirement of Infrastructure, filled Faculty position in place for increase in intake / addition of new courses(s). Also, other requirements as specified in APH 2024-27 needs to be fulfilled at the time of Submission of Application. |
| Q. 13 | Institute is having NBA for Mechanical Engineering since 2018. Can an institute increase the intake of Mechanical Engineering from 180 to 240? |
| Ans. | YES. The institute can increase without utilizing NBA for increasing intake from 180 to 240. However, A Valid NBA will be required for availing other benefits (Multiple Years Approval/ Off Campus facility, etc.,). |
| Q. 14 | Can a Private Institute use a name as National Heritage Institute or Indian Heritage Institute? |
| Ans. | As per the provisions in the APH 2024-27 clause 1.5.4, the self-financing / private Institute cannot use the words such as Indian/ National/ etc. in the name of the institution. |
| Q. 15 | Can a New / Existing Institute use an existing Institute name? |
| Ans. | As per the provisions of clause 1.5.5 of the APH 2024-27, Applicants shall NOT use the names of the existing Institutions within the same State. The existing Institutions having the same names run by the same/different Society/Trust/Company within the State/UT shall at least add the name of the Village/Town/City where it is located as an integral part of the name of the Institution. |
| Q. 16 | Does AICTE allow Arts and Science Courses in the same campus where an Institution offering Engineering Courses operating? |
| Ans. | Yes, Excess facilities can be used to run other Technical or Non Technical Course by taking NOC from AICTE. Institute may apply to council accordingly for NOC (Ref. Chapter -VI for details) |
| Q. 17 | Whether establishment of a new Technical Institution to offer Courses in Engineering and Technology is permissible in Academic Year 2024-25? |



| Ans. | Yes. In case of Engineering and Technology at least THREE core branches (including Multidisciplinary /Region Specific branches/courses) and ONE emerging area course shall be opted. The Core branch and emerging are listed in Annexure-11. |

| Q. 18 | Will the Institution get a chance to submit the compliance of deficiencies (if any) before the scrutiny/Re-Scrutiny committee? |
| Ans. | Yes, Institute can submit the compliance. |
| Q. 19 | (a). Whether MCA/ MBA courses at Arts, Science and Commerce Colleges are eligible to apply for AICTE approval?(b). Whether AICTE approval is needed for running MCA Course in our Arts and Science College? |
| Ans. | For (a) and (b): Yes. Refer Clause 1.3.5 of APH 2024-27. In case of non-Technical Institutions seeking approval for conducting MCA/ MBA and University Departments/ Constituent Colleges seeking approval for conducting MCA/ MBA Programmes apart from their existing Courses, separate building and Principal are NOT required. However, in such cases all other norms (as per APH 2024-27) such as separate Head of the Department, Faculty, Infrastructure, Built-Up area, etc. should be fulfilled. |

| Q. 20 | What is the TER (Technical Education Regulatory Fee) applicable for obtaining AICTE approval for running BCA/BBA/BMS Course(s) in Existing Arts, Commerce and Science College? |
| Ans. | TER Charges as mentioned in Table 2.1 of Chapter-II of APH 2024-27 are Applicable existing Arts, Commerce and Science College already offering BCA/BBA/BMS Course(s). Note: TER Charges as mentioned in Table 1.1 of Chapter-I of APH 2024-27 are NOT Applicable to Existing Arts, Commerce and Science Colleges which are already running BBA/BCA/BMS Courses for obtaining AICTE Approval). |

| Q. 21 | Whether MCA/ MBA Department of Arts, Commerce and Science College is eligible to run BCA/BBA/BMS Courses in addition to MCA/MBA? If Yes, whether separate Application is Required to be submitted for obtaining AICTE Approval? |
|-------|---|
| Ans. | YES. With approval of AICTE, such Institutes can run BCA/BBA/BMS courses also. However, there is NO requirement of Separate Application for Obtaining AICTE Approval. Along with existing MBA/MCA Application [Same PID], Institute can add BBA/BCA/ BMS to take AICTE approval. |
| Q. 22 | Whether Existing Arts, Commerce and Science College already running BCA/BBA/BMS Courses needs to have (appoint) Separate Principal/Director for BCA/BBA/BMS Courses once they take AICTE Approval? |
| Ans. | No. There is NO requirement of Separate Principal/Director for BCA/BBA/BMS Courses even after taking AICTE Approval. However, such Institutes need to have at least One Designated Professor (I/c) for looking after the day to day Academic activities (more or less the same way in which they are presently managed). |
| Q. 23 | Whether Existing Arts, Commerce and Science College already running BCA/BBA/BMS Courses needs to change the Administrative Arrangement Presently they are having once AICTE Approval is Obtained? |
| Ans. | NO. There is NO need to change the Administrative Arrangements. Same Principal / Director who is presently heading the Institute and taking care of the Administrative Arrangements can continue even after AICTE Approval. |
| Q. 24 | Whether Existing Arts, Commerce and Science College already running BCA/BBA/BMS Courses needs to change the Affiliating University which they are Presently having once AICTE Approval is Obtained? |
| Ans. | NO. There is NO need to change the Affiliating University Arrangements which the institute is presently having. Same University will continue to Affiliate BCA/BBA/BMS courses and Award Degrees to all those students who are passing out from such institutes even after AICTE Approval. |
| | AICTE will permit the Institute to have affiliation with different Universities for UG & PG Courses (If required/Applicable). |
| Q. 25 | If the Existing Arts, Commerce and Science College already running BCA/BBA/BMS Courses after obtaining AICTE approval, whether any change in Examination System will come into picture? |
| Ans. | NO. AICTE approval will never change the Existing Examination System of such Institutes. The Existing University will continue to affiliate and conduct Examinations for award of Degrees. |

| Ans. | Yes, after getting approval from AICTE. Simultaneous Course & opening of new Institution is possible. |

| Q. 27 | Whether a New Institution is obligated to appoint a Principal and Faculty at the time of application for approval or subsequent to approval before commencement of the Course? Whether the Faculty to be appointed are for the First Year of the Course or for the entire period of the Course? |
| Ans. | The New Institution is obligated to appoint a Principal and Faculty before the commencement of the Course. The Faculty to be appointed are for the First Year of the Course and it will be progressively done each year so that when an Expert Visit Committee (EVC) conducted any time before the first batch of students has passed out, the availability of the facilities of an Institution as per the norms in Approval Process Handbook 2024-27 be verified. |
| Q. 28 | We have got the first approval for our Institution in 2023-24. But we have NOT admitted students due the delay in getting affiliation. Do we need to apply for EoA? |
| Ans. | Yes, ALL the applicants issued LoA for starting the New Technical Institutions shall apply on AICTE Web- Portal for Extension of Approval (EOA) as specified in the Approval Process Handbook 2024-27 from the next Academic Year onwards, irrespective of the admission of the students or not during the Academic year 2023-24. |
| Q. 29 | a. While applying, I had made a mistake in opting for FN/OCI? How can I rectify the mistake?b. We had applied for the Closure of the Institution, but now we have decided to apply for EoA. How can I revert the application? |
| Ans. | For a and b: There are Two Possibilities. First One is before the Scheduled time announced for submission of application Institution can Reopen the Submitted application and make necessary corrections and resubmit (If the date of Resubmission falls during Penalty Period, then Penalty amount needs to be paid (If Resubmitted within the Scheduled Time then there is NO Penalty need to be paid). Second One is, you can inform AICTE as per the procedure mentioned in Clause 2.3.3 of APH 2024- 27. |
| Q. 30 | We had 25 years of Live Lease at the time of our approval for establishment of new Technical Institution, currently our Live Lease is 5 years. What should we do to get the EoA? |
| Ans. | In case of Institutions having Lease agreement for Land, the Council shall NOT issue EoA from the Year in which the Live Lease is equal to the number of years of the Course having the maximum duration. However, if such Institutions submit the Lease extended for further 30 years with at least 25 years of Live Lease, application for EoA shall be considered. (Refer 2.1 (e) clause) of APH 2024-27. |
| Q. 31 | Our Institution was given Withdrawal of Approval in 2019-20. We are not able to apply under 2024-25 application for EOA. |
| Ans. | You have to apply ONLY as a New Institution in 2024-25. |



| Q. 32 | a. The Institution has been placed under 20% reduction for 2021-22. How to get the full Intake in 2024-25?b. Our Institution was placed under No admission/ No EoA/ Reduction in Intake category in the previous year. How to create 2024-25 application. | |

| Ans. | For (a) and (b): Institutions are required to apply for Restoration on the Web Portal as per the provision in the APH 2024-27. | |
| Q. 33 | Our Institution got approval up to the Academic Year 2020-21 and we were unable to submit application in 2021-22, 2022-23 and 2023-24. We want to apply for EOA during 2024-25. Is our Institution is required to apply for Break in EoA on Web Portal. The same user ID and password can be used. Our Institution taken approval from AICTE for the Engineering Courses in 2011-12. After that we could not take EoA from AICTE due to some reasons. Now we want to apply for EoA in 2024- 25. We have ID and password allotted by AICTE in 2011-12. Can we continue to fill our application on Web Portal of AICTE using that ID and Password? | |
| Ans. | Institutions which have NOT applied for EoA for last SIX YEARS consecutively shall NOT be eligible to apply under Break in EoA and such Institutions shall apply ONLY as a new Technical Institution following appropriate procedure for Closure of the Programmes/ Courses approved. | |
| Q. 34 | Our Institution not applied for EoA in the past 3 years. Can we apply for Break in EoA as well as for a new Programme/Courses? | |
| Ans. | Yes. The Institutions applying under Break in EoA/ Restoration will be permitted to apply for other categories listed under Chapter II/ III/ V of the APH 2024-27. | |
| Q. 35 | After the submission of the application for EoA, if an institute wants to revoke the application and wants to apply under different category provision for such charges any ? | |
| Ans. | Institute can revoke the application and resubmit The application within due date without penalty (If resubmitted within the stipulated Non-Penalty time. If the Institute Resubmits the application after the last date (during the Penalty period) then penalty for late submission of application is applicable. | |
| Q. 36 | Whether All the Existing Institution can Apply for Multiple years Approval as per the Provisions of APH 2024-27? | |
| Ans. | The Existing Institutions which are fulfilling at least ANY ONE of the criteria mentioned in Clause 2.1 of Chapter-II of APH 2024-27 are Only eligible to apply for Multiple Years of AICTE Approval with applicable TER Charges | |

| Q. 37 | Whether All the Existing Institution can Apply for Opening Off Campus as per APH 2024-27? | |
| Ans. | Existing Institutions which are in Existance for more than 10 Years and fulfilling any ONE of the eligibility criteria mentioned in Clause 2.11 of Chapter-II of APH 2024-27. | |
| Q. 38 | Whether Off Campus Unit of the Existing Institute can have the Same Name as that of Main Campus? | |
| Ans. | YES. | |
| Q. 39 | Whether Off Campus Unit of the Existing Institute Need to Deposit Security Deposit? | |



| Ans. | Yes, Security Deposit need to be deposited by the Existing Institute even for Off Campus Unit. |

| Q. 40 | Whether Off Campus Unit of the Existing Institute can have any limit on the Number of Seats /Intake to begin with? |
| Ans. | Yes, Off Campus Unit of the Existing Institute can have the Intake capacity similar to NEW Institute as mentioned in Table 1.2 of Chapter-I of APH 2024-27. Similarly, the Courses / Programs permitted are also on the same lines as that of New Institute. |
| Q. 41 | Whether Off Campus Unit of the Existing Institute can have any limit of Distance with Main Campus and Affiliating Jurisdiction for the Courses? |
| Ans. | There is NO limit of Distance between Main Campus and Off Campus. But the Affiliating University Jurisdiction is applicable to Off Campus. Depending upon the type of Programs/ Courses the Affiliation with Multiple Universities Jurisdiction as applicable is Permitted. |

| Q. 42 | Whether all Existing Institutes are eligible for Working Professional Approvals. |
| Ans. | Existing Institutes meeting at least ANY ONE of the eligibility criteria mentioned in Clause 2.6 (l) of Chapter II of APH 2024-27 are eligible for obtaining Approval for Offering Courses to Working Professionals. |
| Q. 43 | Whether Existing Institutes getting approval for Working Professional required to create additional Infrastructure and Faculty for Offering Courses? |
| Ans. | No Additional Infrastructure is required for Offering Courses for Working Professionals. However, faculty as per the Prevailing Norms is required to be maintained. |
| Q. 44 | Whether Any Separate Guidelines are Issued for Institutes for Offering Courses to Working Professionals? |
| Ans. | YES. AICTE Notified separate Guidelines for Offering Courses to Working Professionals. |
| Q. 45 | Whether Institutes can apply for obtaining Approval to New Courses for offering to Working Professionals? |
| Ans. | NO. Institutes are eligible to get Approval ONLY against the Courses which are already approved for Working Professionals with all seats in Supernumerary Form. |
| Q. 46 | Whether Existing Institutes can offer PG Courses in collaboration with Industries especially in Emerging Area? |
| Ans. | Yes. Existing Institutes can offer PG Courses in collaboration with Industries / Research Organization especially in Emerging Area(Ref. Chapter 3 for details). |
| Q. 47 | Whether Institutes can avail the services of Professor of Practice / Associate Professor of Practice/ Assistant Professor of Practice? |
| Ans. | YES. Up to 10 % of Faculty can be in the form of Professor of Practice / Associate Professor of Practice/ Assistant Professor of Practice in order to teach Emerging Area / Cutting Edge Area Subjects. |
| Q. 48 | Which are the Other Courses available for obtaining AICTE Approval to Offer in ODL/OL Mode? |
| Ans. | Cyber Security and Block Chain are the Two new Courses available to Offer in ODL/OL Mode especially in the form of Post Graduate Diploma / Certificate |



| Q. 49 | Our Intake was reduced to 50% due to the enrollment less than 30% in the past 5 years consecutively. The student admission this year is more than 30%. Should we have to apply for Restoration in 2024-25? |

| Ans. | The Institution falling under this category need not apply for restoration and the Intake shall be automatically reinstated by the Council, if the enrolment becomes more than 30% based on the student enrolment data provided by the Institution on AICTE Portal. |
| Q. 50 | If an Institute not applied for EoA in preceding academic year, How Institute will apply for the next academic year for EoA? |
| Ans. | Such Institute application shall be considered as "Break-in-EoA" and can apply under Break-in-EoA category. |
| Q. 51 | What is the difference between Programme & level? |
| Ans. | Diploma/UG/PG are called Levels and Engineering and Technology /Applied Art and Crafts /Planning/ Design /Hotel Management and Catering Technology/ Management/ Computer Applications are called as Programmes. |
| Q. 52 | The Institute applying under Break-In-EoA shall be eligible to start new Programme/ Level in the existing institution. |
| Ans. | Yes. |
| Q. 53 | We have 5 Diploma Courses; can we apply for conversion of Two Diploma Courses only into Degree Courses? |
| Ans. | No, Partial conversion of Courses / Programmes at any Levels is NOT permitted. However, Institution can apply for New Level and add the courses which your institute is willing to start at new level (Degree Levels) and apply for closure of the two diploma level courses which your institution wants to convert them into degree level courses. |
| Q. 54 | We are having UG and PG Courses in Engineering and Technology. We would like to apply for conversion of our Under Graduate Courses into Diploma Level? Should we have to apply for closure of PG Courses? |
| Ans. | Yes. Your institution can apply for conversion of UG Courses into Diploma level courses. However, PG Courses in Engineering and Technology should be applied for closure simultaneously. |
| Q. 55 | We would like to apply for conversion of our UG Degree Courses into Diploma Courses, but we don't find the nomenclature of certain Courses in Annexure 12. How can we apply? |
| Ans. | Either you have to apply for Closest Available Nomenclature (If exact nomenclatures are Not available). Otherwise such courses need to be applied for Closure. |
| Q. 56 | When an existing Institution applies for a new Programme, whether it have to comply with the built-up area and Infrastructural requirements of the new Programme only for First year and/ or for the entire duration of the new Programme? Whether the existing Institution and the new Programme can share the administrative and amenities areas by creating exclusive Instructional area for the new Programme? |
| Ans. | Please refere to Clause 2.7(g) of APH 2024-27 page no. 17-18. |



| Q. 57 | Whether an Institution offering MBA could be merged with an Institution offering Engineering Courses? |
|-------|--|
| Ans. | Yes, If both the Institutions are run by the same Trust/ Society/ Company. |
| Q. 58 | Whether an Institution offering MBA of One Trust can be merged with an Institution offering Engineering Courses of some other Trust? |
| Ans. | Yes. If such merger are legally permitted as per the legal provisions of both the Trusts looking for their institutions merged. |
| Q. 59 | Can we merge two Institutions located within same Campus/City? |
| Ans. | Yes. |
| Q. 60 | Can we merge few Courses of a Child Institution with Parent Institution and run the Child Institution with the remaining Courses? |
| Ans. | Not permissible. However, after complete Merger the facilities of the Child Institution can be continued to be Used (If required). |
| Q. 61 | Can we merge an Institution running Under Graduate Courses and a Polytechnic in Engineering? |
| Ans. | Yes. However, the concerned State Government and Affiliating University / Board conditions (if any) also needs to be fulfilled before starting the academic session after merger. |
| Q. 62 | How can we apply for addition of seats in Indian / Regional Languages at Diploma/Degree level Courses in Engineering and Technology? |
| Ans. | AICTE permit an addition of ONE division with 30/60 seats to the eligible and interested institutes. Institutions seeking approval shall be permitted for Increase in intake against such courses (as Supernumerary) in which Institution willing to offer in Regional /Indian Languages. Institution have to apply on portal by following the instructions applicable for Regional /Indian Languages. |
| Q. 63 | We have One Course with valid NBA accreditation. How many increase/ new Course our Institution is eligible? |
| Ans. | Institutions shall be eligible for new Course(s)/ expansion of existing Course(s) without NBA Accredited Courses. Further, for introduction of new course, Institute should run minimum THREE core branches (including Multidisciplinary courses / Region specific courses) Refer Clause 2.6 of APH 2024-27 for more details (other conditions to be fulfilled) |
| Q. 64 | Our Institution has valid NBA accredited Courses. Is it necessary to upload valid NBA letter on portal and send hard copy to Regional Office? |
| Ans. | Yes. The information related to validity of NBA accredited Courses need to be provided on portal. However hard copy need not be sent to Regional /Head Office. Institution need to produce the additional documents including NBA letter at the time of Scrutiny (as applicable depending upon the type of application submitted for approval). |



| Q. 65 | Our Institution has applied for NBA, whether we are eligible for adding a new Course? |
|-------|---|
| Ans. | Yes, subject to the fulfilment of other norms as per APH 2024-25 (infrastructure, faculty, etc). |
| Q. 66 | How many seats allowed to an institution under NRI category? |
| Ans. | Five percent (5%) of seats within "Approval Intake" shall be allowed for admission under NRI Category. |
| Q. 67 | Our Institution has obtained Accreditation for two Courses which are valid till 2023. I haveused these Courses for adding two new Courses during 2022-23. If my Institution got the renewal of accreditation again after inspection during 2023 for the same Courses, can I apply for the introduction of New Course/ increase in Intake using it |
| Ans. | NBA Accredited courses is NOT required for adding New Course/ increase in Intake. However, the Institution needs to fulfill other conditions as specified in APH 2024-27 (CLAUSE 2.6). Further for introduction of new course/Increase in intake, Institute should run minimum three core branches. |
| Q. 68 | What does it mean by EoA based on self-Disclosure? |
| Ans. | An Institute given approval earlier can apply for extension of approval by providing self- declaration regarding availability of facilities as applicable as per AICTE Norms & Requirements (affidavit-2) of APH 2024-27. |
| Q. 69 | We are offering Courses in Design Programme. We are not eligible to apply for NBA. How can we apply for new PG Course? |
| Ans. | The Institutions offering the Courses in Applied Arts and Crafts and Design shall be eligible to apply for new Course(s) at the Post Graduate Level only after two batches of students' passout and the same shall be permitted for a maximum of FIVE Courses / Divisions, subject to "Zero Deficiency" based on Self-Disclosure on AICTE Web-Portal. However, for every Post Graduate Course, there should be at least one Professor with Ph.D. qualification. In case of non-availability of qualified Professor, an Associate Professor may be considered. As and when accreditation for the above Courses is started by the NBA, such Institutions who have been approved by the AICTE to run Course(s) at the Post Graduate Level shall obtain NBA accreditation within TWO years. |
