OBC candidates will bring with them income certificate (Non-creamy layer) for the Financial Year ending 31 st March, 2021 on the prescribed format (copy enclosed). Candidates belonging to EWS will bring with them income certificate for the Financial Year ending 31 st March, 2021 on the prescribed format (copy enclosed).
4.	Latest Pay Slip indicating (i) Scale of Pay/Pay Band/ Pay matrix level of the present post held (ii) Basic Pay (iii) DA (iv)HRA (v) CCA (vi) Grade Pay as applicable.
