MEMORANDUM OF UNDERSTANDING (MoU)

Between

**All India Council for Technical
Education, New Delhi**

And

IIT, Kanpur

24th February, 2020



This Memorandum of Understanding (MoU) is effective for a period of one year from 24/02/2020 to 23/02/2021 establish an affiliation by and **between ALL INDIA COUNCIL FOR TECHNICAL EDUCATION (AICTE)**, statutory body established by an Act of Parliament (52 of 1987) under Ministry of Human Resource Development, Government of India for the purpose of planning, promotion and regulation of Technical education system in the country hereinafter referred to as AICTE, of the FIRST PART and **Indian Institute of Technology, Kanpur**, a leading institute of India that is focused on education & research in science and technology, established under an Act of the Parliament of the Republic of India, having its office at Kanpur, India hereinafter referred to as IIT, Kanpur, of the SECOND PART, for the purpose of enhancing skill of students through internships.

Preamble

WHEREAS, AICTE and IIT Kanpur have many areas of common interest in Engineering and Sciences, considerable advantage may be gained from their pursuit on a collaborative basis in the fields of academics, education and research. Hence, AICTE and IIT Kanpur have decided to enter into this Memorandum of understanding (hereinafter referred to as MoU), which defines the framework for the cooperation of the two institutions set out in the following sections.

ARTICLE 1: OBJECTIVE

Both Institutes agree to develop the following collaborative activities in the academic areas of mutual interest, on the basis of equality and reciprocity.

A. IIT Kanpur

- IIT Kanpur to enroll 100 Interns under its Non-Degree Student Programme from students of Jammu & Kashmir.
- IIT Kanpur will work out the detailed programme with popular science lectures from distinguished faculty from IIT Kanpur as well as outside of IIT Kanpur apart from research interactions and visit to laboratories. Centre for Educational Technology (CET) will also demonstrate them model experiments in physics and chemistry.



Yoga and meditation classes / sports events / group physical activities for the willing students will be organized in the morning/evening.

The interns will start their internships from 10th May 2020 - 10th July 2020.

The internships will be in the field of research primarily.

The internships will be done under various professors of IIT Kanpur.

The accommodation and food arrangements for these interns will be made in the various hostels of IIT Kanpur.

B. AICTE

- AICTE will make arrangements for the to and fro train travel of the students.
- The selection of the students will be purely based on merit and will be done via AICTE's internship portal.

ARTICLE 2: COORDINATION

Each organization shall appoint one member of its teaching/research faculty/officer to coordinate the programme on its behalf. Further, a coordination committee consisting of a programme coordinator from the side of AICTE, and a programme coordinator from the side of IIT Kanpur, will periodically review and identify ways to strengthen cooperation between the two institutions.

ARTICLE 3: CONFIDENTIAL INFORMATION

AICTE and IIT Kanpur do not absolve any confidential information during the research activity.

ARTICLE 4: INTELLECTUAL PROPERTY RIGHTS

Ownership of any intellectual property (including but not limited to confidential information, know-how, patents, copyrights, design rights, rights relating to computer software, and any other industrial or intellectual property rights) developed jointly during the course of this MOU shall be vested in both institutes to this Memorandum. Both organizations shall have the joint right to determine the commercial exploitation and disposition of such intellectual



property, and both organizations shall make joint applications for the registration of the same. Before any registration or commercialization of any intellectual property takes place, the institutes agree to reach a separate agreement covering issues such as exploitation rights and revenue sharing.

Any publication regarding such intellectual property shall only be possible with the prior written consent of both organizations, such consent not to be unreasonably withheld.

ARTICLE 5: VALIDITY

The Memorandum shall remain in force for a period of one year commencing from effective date. Institutions may extend the term by written agreement signed by both after review.

ARTICLE 6: TERMINATION

Either institution may terminate the MoU by giving written notice of six months in advance to the other institution. Once terminated, neither, AICTE nor IIT Kanpur will be responsible for any losses, financial or otherwise, which the other institutions may suffer. However, AICTE and IITK will ensure that the provisions of this Memorandum shall continue to apply to all activities in progress until their completion.

ARTICLE 7: AMENDMENTS/MODIFICATIONS

This MoU may be amended or modified by a written agreement signed by the representatives of both institutes.

ARTICLE 8: ADHERENCE TO LAWS

Participating faculties, staff and students involved in any activities under this Memorandum must adhere to the law of the host countries and rules and regulations of the institutions.

ARTICLE 9: LEGAL EFFECT

Nothing in this Memorandum shall be construed as creating any legal Relationship between the institutes. This Memorandum is a statement of intent to foster genuine and mutually beneficial collaboration.




ARTICLE 10: DISPUTE RESOLUTION

In case, there be a dispute relating to any aspect of academic cooperation, Chairman, AICTE and Director, IIT Kanpur will jointly resolve the dispute in a spirit of independence, mutual respect, and shared responsibility. AICTE and IIT Kanpur welcome the establishment of this Memorandum for cooperation and jointly agree to the provisions as set out above.
