Sub.: Clarification regarding inclusion of FDP Programme(s) by Indian Society for Technical Education (ISTE) – Training requirement for promotion of faculty in technical institutions – reg.

Sir/ Madam,

This is with reference to the provision given in Annexure-III of AICTE Gazette Notification dated 01.03.2019 (page 44-45) relating to training requirements for promotion of teachers from all the disciplines in Degree level technical institutions. It has been provided that completion of training requirements for different level of faculty in the relevant area recognized by AICTE/ UGC/ TEQIP/ NITTTR/ PMMMNMTT/ IISc /IIT/ University/ Government/ DTE/ Board of Technical Education/ CoA/ IIA/ SPA/ ITPI/ NRCs/ ARPIT research organization/ other Institute of National Importance/ Design Studio. However, the Faculty Development Programmes (FDPs) conducted by Indian Society for Technical Education (ISTE), which is a National Professional Society, have not been specifically mentioned in Annexure-III of AICTE Gazette Notification dated 01.03.2019.

The AICTE in its 144th meeting of the Executive Committee (EC) has considered the above issue and after its deliberations approved the inclusion of training programmes (FDPs) conducted by ISTE for the faculty of technical institutions for the purpose of their promotions/ CAS. All concerned are therefore informed to recognize trainings conducted by ISTE also so that faculty members who attend these programmes organized by it do not face any difficulty in the matter of their promotion/ CAS.
